The Government of India has received a **loan** from the International Bank for Reconstruction & Development towards the cost of **Karnataka Municipal Reforms Project** and intends to apply a part of the funds to cover eligible payments under the contracts for construction of works as detailed below. Bidding is open to all bidders from eligible source countries as defined in the *IBRD Guidelines for Procurement*. Bidders from India should, however, be registered with the Government of Karnataka or other State Governments/ Government of India, or State/Central Government Undertakings. **Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instructions to Bidders to qualify for the award of the contract.**

Bidding documents (and additional copies) may be purchased from **The Commissioner, City Municipal Council, Madikeri, Kodagu District** from 13.11.2008 to 15.12.2008 for a non-refundable fee as indicated (3 sets), in the form of cash or Demand Draft on any Scheduled bank payable at Madikeri in favour of "The Commissioner, City Municipal Council, Madikeri". Interested bidders may obtain further information at the same address during normal office hours between 10.00 Hrs to 17.30 Hrs. Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs.250/-. The Commissioner, City Municipal Council, Madikeri will not take responsibility for the postal delay if any, in the delivery of the documents or non-receipt of the same.
4. Bids must be accompanied by security of the amount specified for the works in the table below, drawn in favour of "The Commissioner, City Municipal Council, Madikeri". Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid.
5. Bids must be delivered to : The Commissioner, City Municipal Council, Madikeri on or before 15.00 Hrs on 16.12.2008 and will be opened on the same day at 15.30 Hrs, in the presence of the bidders who wish to attend. If the office happens to be closed on the date of receipt of the

bids as specified, the bids will be received and opened on the next working day at the same time and venue.

6. A **Pre-bid Meeting** will be held on 29.11.2008 at 11.00 Hrs. at Office of “The Commissioner, City Municipal Council, Madikeri ”, to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of ‘Instructions to Bidders’ of the bidding document.
